### I. Department Organization and Administration

In April, 1976, Professor Michel A. Ibrahim was appointed Chairman of the Department of Epidemiology, succeeding Professor John C. Cassel, who had chaired the Department since 1959. Professor Ibrahim had been Acting Chairman since the resignation of Professor Cassel in April, 1975. A 15-member Search Committee carefully considered the qualifications of many possible candidates during the course of the year. The six most outstanding candidates visited the Department for two or three days each beginning in the Fall of 1975. These visits not only functioned in the choice of a new Chairman, but also brought the Department into contact with the thinking of outstanding epidemiologists from other parts of the country and the world.

During this year, the Department maintained its continuity under the administrative reorganization initiated during the last year of Dr. Cassel's Chairmanship. This reorganization involved the delegation of many responsibilities to committees which included staff and students as well as faculty members. This organization has functioned well in broadening the base of participation and decision making and in facilitating the teaching, research, and service of the department. A brief statement of the functions of the various committees follows.

The Graduate Studies and Curriculum Committee is responsible for determining the extent to which the philosophy of the department is implemented in its teaching program. This committee, whenever necessary, reviews and evaluates courses and makes recommendations to the faculty regarding additions or deletions. It prepares the agenda for the annual Departmental retreat, and advises the Department with respect to the implementation of the recommendations of the retreat.

The Admissions Committee functions as an advisory group to the Chairman on student applications for admission and for assignment to the various teaching programs of the Department.

The Field Training and Technical Assistance Committee oversees requests for technical assistance from State and Local Agencies

which come to the Department, and identifies appropriate faculty members and students for the various areas of consultation.

The Seminar Committee is responsible for organizing weekly departmental seminars and for inviting appropriate lecturers to speak on topics of interest to the faculty and students.

The Student Affairs Committee supervises and reviews all students prior to the formation of a doctoral committee for the student. This committee is responsible for scheduling masters examinations, and for serving as ombudsman of the department in an attempt to discuss and resolve whatever problems may arise.

The Space and Resource Committee is a service committee with responsibility for space allocation and needs, library and journal resources within the Department, and documentation of Departmental activities, including the collection of data on publications by faculty members, theses, dissertations, and State and National activities of the members of the Department.

The Personnel and Budget Committee is the only committee which does not include students, since it deals with confidential personnel and budgetary matters. This committee serves as a sounding board for the problems of staff members and makes recommendations to the Chairman with respect to these problems.

## II. Instructional Programs

#### A. Courses and Curricula

1. Major Changes During the Year

The major teaching programs of the department continued during the current year: the programs in general epidemiology, environmental epidemiology, psychosocial epidemiology, clinical epidemiology, health services research, and the epidemiology of population dynamics. New courses offered during the year were:

EPID 251 - Epidemiologic Methods in Population - Omran. EPID 268 - Advanced Methods in Epidemiology - Tyroler.

EPID 276 - Advanced Environmental Epidemiology - Shy.

EPID 270 - Applications of Psychological Theory and Research to Health - James.

### 2. New Programs Being Planned

A new program of teaching and research is being planned in cancer epidemiology in collaboration with the Cancer Center, the School of Medicine, U.N.C.; and the Division of Community Health Services, School of Medicine, Duke University. An initial informal series of seminars on cancer epidemiology is being offered in the late spring and early summer of 1976.

While the Department continues to participate in the off-campus MPH programs, no courses in epidemiology were required for these programs during the current year.

## VI. Special Plans, Departmental Distinctions, Developing Trends

The philosophy guiding the educational program in this department is that it is no longer feasible or desirable to attempt to teach all the known facts in any given discipline; it is unfeasible because there are too many facts to be remembered and undesirable because many of them may change tomorrow. If such an assumption is true for any single discipline, it is obviously even more valid in a department which is attempting to integrate many of the diverse sciences to man (particularly the biological, and a number of the behavioral sciences) for the study of the phenomena of health and disease in social groups.

Accordingly, the faculty has accepted the fact that many students will graduate with gaps in their knowledge and that a fixed or required curriculum no longer makes educational sense. Thus, beyond the few courses required by the School, the department has no fixed requirements. In lieu of such requirements, there is an expectation that as rapidly as possible, each student, in consultation with his advisor, will specify a series of issues or concerns that are central to his or her interests. It is then the responsibility of the faculty, together with the student, to delineate the competencies that will be required to resolve these issues. Finally, the faculty have the responsibility of indicating to the student the various options open to obtain such competencies. can include formal courses within and outside the department, informal seminars, directed reading, participation in an ongoing departmental research project, exploration of data sets available within the department and participation in clinical activities.

The major evidence required to determine whether a student has benefited from such an experience is documentation through a research project that the original issue has been resolved (usually this would apply to doctoral candidates) or in the case of master's candidates, the development of viable approaches which if applied could resolve the issue.
