Dear Dr. Schoenbach:

During a July 17 memorial service held to honor Jim Bernstein's life and work, his family and hundreds of friends, state and community leaders, and health professionals reflected on the many accomplishments of a man who, for all practical purposes, invented rural health care as we know it today. It was his vision, his commitment and his passion that led North Carolina to become a model of innovation for the community-driven care of poor, isolated and underserved populations.

In an effort to help sustain his vision and as a tribute to his work, The Jim Bernstein Health Leadership Fund has been established. It is an initiative designed to expand, strengthen and build upon the corps of community health leaders statewide that Jim nurtured. The Fund will be administered by the N.C. Foundation for Advanced Health Programs, and, per Jim's personal request, will seek to:

- Develop future leaders by supporting up-and-coming professionals (clinicians, administrators and others) in the latter stages of their education or training and those already at work in rural and underserved communities throughout the state;
- Build and strengthen relationships among rural healthcare leaders by bringing them together through educational and networking conferences and helping them learn from one another; and
- Provide college financial aid for children of rural health center employees, both to recognize and thank those professionals for their contributions and to invest in their children's — and North Carolina's — future.

Our goal in this first year is to raise sufficient resources to establish the Fund, devote resources to its inaugural programs and set aside funding to help seed additional initiatives in the future. Many of you and your organizations touched by Jim's compassionate spirit or his works have already contributed to the Fund, and we appreciate that leadership. If you have not yet had an opportunity to contribute, we ask that you review the enclosed pledge card and consider how you might help us develop future rural health leaders to carry on a noble legacy of work.

North Carolina is a beacon for those seeking to improve rural health care, and we have Jim Bernstein to thank for that. It's now our charge to keep that light burning, to illuminate the way for others who will provide high-quality health care for our neighbors most at risk throughout North Carolina.
